- Dogs must be current on some sort of flea preventative (for example, Nexguard, Advantage, or Frontline) due to the nature of our set up (cageless grooming and doggie daycare). We encourage a veterinary prescribed flea preventive for optimal results. Even if your dog normally does not contract fleas at home, in an environment where groups of dogs are together the risk is much greater, and this is the best way we've found to protect our furry friends.

Medical Information

Due to the open play environment at Peace Paws there is an increased risk of transmission of ailments such as coughs, colds, and parasites when dogs come into contact with one another. It is advisable to ensure that your dog is on a deworming protocol with your veterinarian. Just like human children in daycare, risks of upper respiratory infections occur in group play at dog parks, on sidewalks, or potentially at Peace Paws LLC.

Peace Paws will not de-matt any dog if it is determined that it will cause inordinate pain, discomfort or stress to your dog.

Shave-Down Authorization

This authorization is given in the event that, after a thorough evaluation of your pet's coat, the grooming staff determines that a shave down is the best recourse for grooming your pet. During a shave down, even with special care given to safety, it is possible for your pet to be nicked, cut, or get razor burn. Shaving a pet will also dramatically change the pet's appearance and the hair will be very close to the skin. This may expose pre-existing skin conditions. Your signature acknowledges that you are aware of the risks, releases Peace Paws LLC from any responsibility for any trauma to the pet as a result of the shave down and authorizes a shave down if it is deemed necessary by the grooming staff.

No dog will be released until all charges are paid in full. Cancellation and No Call, No Show fees may be applied for reservations canceled less than 24 hours prior to a scheduled reservation.

Costs for repairs to property will be my sole responsibility. No aggression, by dogs or humans, will be tolerated and are cause for immediate dismissal.
